Measuring sustainability impact for cooperative and mutual insurers

ICMIF-calibrated SDG Calculator - *a tool to measure impact and report on progress towards Insurance SDGs*: **Alicia Montoya, Head Research Commercialisation, Swiss Re Institute**

Sustainable protection has been long considered the keystone of mutual/cooperative insurance, giving security to policyholders and stability to economies.

The concept of sustainability is now being translated into measurable outcomes for insurance, using the Sustainable Development Goals and/or ESG criteria. These are increasingly expected and, in some cases, becoming mandatory. Measuring insurance impact is key to enabling the real implementation of sustainability and for companies' responsibility and accountability.

How can mutuals/cooperatives differentiate themselves and stay ahead of the market? The recently launched ICMIF-calibrated Insurance SDG Calculator enables ICMIF mutuals and cooperatives to assess their own iSDG impact against a set of ICMIF-calibrated indicators that reflect mutual values and strategic focal areas, such as risk prevention and inclusive insurance.

This new and unique tool will be presented by **Alicia Montoya**, who heads Swiss Re Institute's Research Commercialization unit. Alicia also leads Swiss Re's Quantum Cities™ initiative, using tech to foster sustainable economies and societies.
